MEDICO-LEGAL REPORTS

Medico-legal reports are provided for courts, tribunals and hearings where an independent medical opinion is required.

The purpose of high quality reports is to ensure that an accurate medical diagnosis is provided – which is often lacking. Leading from the diagnosis, treatment options will be provided with an aim to return the claimant to pre-accident state. Again, this is rarely provided in current reporting.

Once a steady state has been achieved medically, a disability assessment can be made, if relevant to the claimant's condition.



Mr Quaile has at heart the concept of advising the court on the most effective way of returning the claimant to their pre-injury life.

Reports are provided in an efficient timescale during which Mr Quaile's office can be contacted for updates. Examinations are usually conducted in a medical facility, but on occasion and with prior arrangement a domiciliary visit can be made.

BACK TO HEALTH
